### LEVELS OF MISCONDUCT

LEVELS	OFFENCE	CONSEQUENCE
<b>LEVEL 1 (Low Risk)</b>	<ul style="list-style-type: none"><li>• Being late to class repeatedly</li><li>• Not wearing proper uniform</li><li>• Not bringing books/materials</li><li>• Eating or talking in class without permission and disrupting lessons.</li><li>• Misusing mobile phones/digital devices</li></ul>	<ul style="list-style-type: none"><li>• Verbal warning</li><li>• Written warning to parents</li><li>• Meeting with parents</li></ul>
<b>LEVEL 2 (Medium risk)</b>	<ul style="list-style-type: none"><li>• Leaving class without permission</li><li>• Skipping school events</li><li>• Fighting or threatening others</li><li>• Using rude or insulting language</li><li>• Minor damage to property</li><li>• Bringing vaping/tobacco items</li></ul>	<ul style="list-style-type: none"><li>• Written warning</li><li>• Student/parent undertakings</li><li>• Onsite suspension (1-3 days)</li></ul>
<b>LEVEL 3 (High risk)</b>	<ul style="list-style-type: none"><li>• Bullying and assault without injury</li><li>• Cheating or plagiarism</li><li>• Leaving school premises without permission</li><li>• Major vandalism</li><li>• Recording others without permission</li></ul>	<ul style="list-style-type: none"><li>• Immediate onsite or offsite suspension</li><li>• Final written warning</li><li>• Behaviour plan agreed with Behaviour Management Committee</li></ul>
<b>LEVEL 4 (Extremely High risk)</b>	<ul style="list-style-type: none"><li>• Possessing weapons</li><li>• Unsolicited verbal or physical behavior of inappropriate nature.</li><li>• Serious physical assault and theft.</li><li>• Sharing unlawful or inappropriate content</li><li>• Using or distributing drugs, alcohol, or illegal substances</li><li>• Setting fires</li></ul>	<ul style="list-style-type: none"><li>• Immediate offsite suspension</li><li>• Possible expulsion (after investigation and ADEK approval)</li></ul>
